

**KSG ISP-410: Intervention and Peacekeeping**

**Monica Duffy Toft**

Spring 2003

**Description:**

This course examines interventions and peacekeeping in civil wars and violence. It addresses the international legal basis for intervention by outside parties, as well as state interests and capacity. Multilateral and unilateral intervention is considered including the role of the United Nations, regional organizations, and NGOs. The cases discussed include Haiti, Somalia, and Rwanda. As part of the course requirements, students participate in a group exercise to come up with policy alternatives to the 1994 genocide in Rwanda.
